NOVEMBER ACTIVITIES

Family/Beginner Bird Walk at Turtle Bay Saturday, Nov 3 @ 9:00 am We invite beginners of all ages to our introductory walks on the first Saturday of each month. Second Saturday Bird Walk at Cascade Community Park, Nov 10 @ 8:00 am. Located at the end of Girvan Road east off Hwy 273, this small park borders the Sacramento River at the confluence of Olney Creek. The ½ mile paved trail has several dirt trails providing access to the river and the mouth of Olney Creek. Eighty winter resident species have been seen, including Hooded Merganser, Merlin, Fox Sparrow, Yellow-billed Magpie (they used to be abundant in a large Valley Oak in the NE corner of the park; a few survived the virus), plus the usual backyard species. Meet your leaders Jeannette and Harvey Carroll at the park at 8:00am for this 1/2-day walk.

Mid-week Field Trip at Clover Creek, Nov 15
@ 8:00 am In previous Novembers, Clover
Creek Preserve has had some real treats for
birders (though not guaranteed), including
White-tailed Kite, Cedar Waxwing and Say's
Phoebe. More likely are a variety of sparrows
such as Fox Sparrow and Lark Sparrow.
Several duck species will be there: Ruddy Duck,
Ring-necked Duck, occasionally Green-winged
Teal and others. The vernal pools (if filled) may

attract Greater and Lesser Yellowlegs. Open space birds such as American Pipit, Western Bluebird and Western Meadowlark are usual. Join trip leader **Linda Aldrich** in the parking lot off Shasta View at Venus Street at 8:00 am for this half-day trip.

GENERAL MEETING

Tuesday, Dec 11 @ 7:00 pm Birds, Mummies and Geoglyphs of Far Northern Chile.

Catherine Camp and Bill Oliver are going to take you on a tour of Far Northern Chile, where the Atacama Desert (the driest, hottest desert on earth) and the Altiplano (a high Andean steppe) exist within a few miles of the Pacific Ocean. These fascinating and unusual geographies have created a wide variety of birds and distinct, ancient cultures. On the coast we will look at the 8000-year-old Chinchorro culture, including mummies from before 5000 BC. And on the Atacama Desert we'll look at a few of the hundreds of geoglyphs, 400 to 1200 AD drawings on stone and arrangements of stone, some of which cover enormous areas on the slopes of hills and on the desert floor.

TRIP REPORTS

Manzanita Lake, Sept 29 Eight enthusiastic birders enjoyed a cool morning on a gorgeous, mostly sunny day, exploring the bird activity from the Manzanita Lake Trail. Some apprehension regarding how many species would be available was quickly dashed as several Clark's Nutcrackers foraged in the treetops around the visitor center, a huge flock of Band-tailed Pigeons flew overhead, and several other species were observed from the parking lot.

As we headed down to the lake from the visitor center, a Peregrine Falcon flew overhead and a Bald Eagle was seen perched on a snag. We walked down a trail to Manzanita Creek to find four Fox Sparrows and an American Dipper.

Little did we know, those four Fox Sparrows were only a preview of the more than forty more we would encounter.

Overall, we observed thirty-seven species of birds. Besides those previously mentioned, the best birds spotted were Wilson's Warbler, Common Yellowthroat, Evening Grosbeak, Golden-crowned Kinglet, Wilson's Snipe, Merlin and Cooper's Hawk.

Northern California Council Meeting, Oct 13th Wintu sent representative Sally NeSmith to the Northern California Council Meeting in Quincy on October 13th.

After a get-to-know-you dinner on Friday night, Saturday morning started the meeting with a very cold, frosty bird walk in a meadow at Spanish Ranch Road.

The meeting was held on the Feather River Campus and had representatives from Red Bud, Plumas, Altacal, Mendocino Coast, Wintu and State Audubon. We reviewed legislative issues that Audubon supports and for which it advocates.

A great deal of the meeting was about Grebes. Plumas, Altacal and Red Bud have grants to study the Western and Clark's Grebes that nest on Lake Almanor, Eagle Lake, Clear Lake and other smaller lakes in their areas. They presented their data from over the years and the dismaying conclusion was that there were almost no young hatched this year at Lake Almanor.

California Audubon has requested that PG&E (managers of the dam levels) mitigate the losses by releasing less water during the critical fledgling stage (late July/August). When PG&E lowers the lake too fast during this time, the Grebes lose their nests, which require 6 inches to several feet of water to float upon. (Interesting fact: Grebes don't fly while nesting only during migration). The Red Bud chapter study also reported very low numbers of new chicks on Clear Lake and speculated the fires during that critical time prevented chicks coming to term.

Political action - letters, articles and discussions - was of course encouraged.

During the afternoon session, each of the groups gave an update on what they have accomplished. Of course, I bragged about Wintu Audubon.

Return of the Salmon Festival, Part 2 After helping set up our booth at the Salmon Festival, George and I took the opportunity to bird from the fish hatchery to Battle Creek State Wildlife Area. We tallied 35 species including a flock of 22 Cedar Waxwings, several Pied-billed Grebes, Marsh Wrens and Common Gallinules, a single Belted Kingfisher, scores of Redwinged and Brewer's Blackbirds, a Bald Eagle, and at least 70 Turkey Vultures circling overhead. Best birds were a Sora, a Lincoln Sparrow and three Wilson's Snipes that were spotted flying over different areas of the marsh.

forage fish and invertebrates - an important part of seabird diets. Here is an excerpt from the letter Dan signed on behalf of Wintu Audubon: "Dear Legislator: On behalf of the Audubon-affiliated organizations and our more than one million members who care about birds, we stand together to oppose any legislation that would increase the chances of overfishing and we support enhanced protections for seabirds and their prey. Seabirds are currently threatened by oil spills, contaminants, habitat disruption, incidental take, and overfishing and we need to create solutions to protect seabirds and sustain their prey.

Over the past four decades, Republicans and Democrats have worked together to tackle chronic overfishing of our nation's fisheries by signing into law and reauthorizing the MSA. This law protects our Nation's ocean fisheries and has been successful for decades. Through implementation of the MSA, fishery managers have recovered 44 fish populations and ensured that overfishing is at an all-time low.

The U.S. House of Representatives recently passed H.R. 200, the "Strengthening Fishing Communities and Increasing Flexibility in Fisheries Management Act." We oppose this legislation."
